

## The Forever Flying Club Terms of Service

### A. Fare Availability

1. The Forever Flying Club (hereinafter referred to as "the Club") shall not be liable for any discrepancies between real-time data provided on the [theforeverflyingclub.com](http://theforeverflyingclub.com) website (hereinafter referred to as "the website") and pricing or fare data obtained when attempting to confirm the booking of common carrier airfare directly through the airline. Airfare and ticket availability are dynamic; therefore, information provided on the website, although reliable, may change between viewing available airfare and confirming a reservation with the airline. The Club is designed to function as a data aggregation tool to sort and filter publicly available fare buckets.
2. Airfare shown on the website or other subdomains may require that each passenger be enrolled in special discount clubs or subscription-based unlimited travel programs through common carriers/airlines. The airfare cost shown on the website reflects the lowest available airfare for given search dates for customers with memberships to said programs.
3. The Club does not issue, sell, or confirm any airline tickets or common carrier fare.

### B. Personal Use Policy

1. A subscription to the Club is intended for use by one individual. Standard subscription plans require that you enroll and confirm via a registered email address, and data pertaining to location and number of searches per account may be collected to enforce this policy.
2. The unlimited search feature is for personal use. The Club reserves the right to limit account holders who show trends of abuse or password sharing. These members may have their account restricted, deleted, or search numbers limited without any refund offered.
3. Any intellectual property, including but not limited to blog posts, instructional videos, how-to guides, or other miscellaneous material, is meant for private, paid usage by subscribers to this website on this website. Members who show trends of sharing these materials may be subject to account suspension or deletion without refund.

4. Users suspected of password sharing or not following personal use guidelines will receive a one-time 30-day warning to the email address on file before any action is taken on their account as mentioned in B.2.

### C. Fees and Payments

1. The Club reserves the right to offer promotional subscription prices without notice, and these special offers may only be available to new subscribers.
2. Members attempting to circumvent any promotional terms may be subject to account closure or suspension without notice.
3. A 30-day notice will be sent to any active subscriber at the time any price increase is established. Price increases will not affect any prepaid annual or seasonal plans until the end of the current enrollment period.
4. Members whose payment method expires or does not process may not regain access to the Club and its services until the payment method is reestablished and the subscription has been paid in full.
5. No Refunds. PAYMENTS ARE NONREFUNDABLE, AND THERE ARE NO REFUNDS OR CREDITS FOR PARTIALLY USED PERIODS. Following any cancellation, however, you will continue to have access to the service through the end of your current billing period unless otherwise notified.

1. The Club may collect and monitor your search trends and history for the improvement of the website.
2. Your personal data will not be sold, bartered, or traded to any advertising agency or corporation. Personal data includes Name, Email Address, and information relating to payment methods, which is neither stored nor shared with the Club

from the payment processor. Personal data does not include search trends of anonymous members or any anonymized data.

#### F. Equipment and Related Costs

1. You are responsible for obtaining and maintaining all telephone, computer hardware, internet, or cell data access and other services needed to access and use this service. The Club shall not be liable for any incurred costs for discrepancies of data between what is displayed on the website and real-time data provided by common carriers (Airline).
